### **Indian Economy:**

Fitch improves India's FY25 GDP forecast to 7%



Fitch Ratings has revised India's gross domestic product (GDP) growth forecast upward for the ongoing and the next financial year, anticipating the economy will sustain its robust expansion. India's real GDP for FY25 is projected to grow by 7%, marking a 0.5%-point upward revision. Fitch predicts a growth rate of 7.8% in FY24 and 7.0% in FY25 for India.

**Indian Economy Resilient: NCAER Report** 



A report by the National Council of Applied Economic Research (NCAER) has highlighted the resilience of the Indian economy. The Purchasing Manager's Index (PMI) for services has been consistently increasing, while manufacturing has also picked up momentum. The composite PMI, which is a combined measure of both these indicators, rose to 61.2 in January from 58.5 in December 2023.

## Morgan Stanley raises India's GDP growth forecast for FY25 to 6.8%

Global brokerage firm Morgan Stanley has revised its GDP growth forecasts for India, foreseeing an upward trajectory for FY25 and the ongoing FY24. The firm now expects GDP growth to reach 6.8% in FY25, up from the previous estimate of 6.5%, while projecting a growth rate of 7.9% for FY24.

## Indian Space Research Organization successfully tests Reusable Launch Vehicle 'Pushpak'

The Indian Space Research Organization (ISRO) has successfully executed the landing mission of its Reusable Launch Vehicle (RLV) known as 'Pushpak' from the Aeronautical Test Range (ATR) in Challakere, Karnataka. The RLV was transported to an altitude of approximately 4.5 km by an Indian Air Force helicopter and was released after meeting the specified pillbox parameters. ISRO had previously announced that this mission is part of the space agency's endeavours to develop crucial technologies for a fully reusable launch vehicle, aiming to facilitate cost-effective access to space. The Pushpak RLV has been meticulously designed as a fully reusable singlevehicle, stage-to-orbit (SSTO) incorporating components from advanced technology.






